I was proud to be involved in the process, and impressed by what I saw of the activities you coordinated for the external review. Also, you have embraced the feedback the reviewers have offered with open and creative minds and I am delighted to see such a detailed and ambitious action plan. I know you can achieve all your goals here!

I am glad to see recognition of the need to update specific areas of the curriculum. Staying relevant to current practice and trends is the key to design training, to be sure. And I am happy to endorse the suggestion that the program adopt a Program Advisory Committee to help ensure a regular industry connection informs the learning experience.

I want to recognize and encourage your stated commitment to quality improvement through the review of assessment methods and the intention to work toward some consistency in standards throughout the program. And I am personally delighted by the requirement of 20th Century Design History, a long standing gap in the curriculum.

Marketing to the mature student population can be revised to determine if this is a target audience the program wants to pay more attention to.	Self-Study p 8 External Review p 3	The External Review Committee considers that while this is a good goal to work towards, the focus needs to be on other areas of the review like update the web pages with current information about "career opportunities" for example.
Consider if a writing component should be included for acceptance to the program to demonstrate the depth of knowledge and writing communications skills of the applicants.	Self-Study p 8 External Review p 3	The External Review Committee felt ambivalent about this finding, and some of the concerns are being addressed by the changes made by the English Department.
To better writing skills, Faculty should evaluate the possibility of substituting one elective to an English/Writing requirement so there are 3 English courses in total to graduate and add more English and Communications courses as option to fulfill the English credits to graduate. Examine the possibility of including written components as part of the development and process (such as briefs) for final projects in each course	Self-Study p 13 External Review p 4	The Committee did not support the addition of required English or Communications courses. After talking to alumni and students, they found that the electives that are part of the program are crucial to the success of the students and their ability to create their own career pathways.  Adding an additional required English or Communications course may be helpful for some students, but would be detrimental to others. Allowing students to choose their own electives is one of the strengths of this program.
Consider written communications as one of the program learning outcomes.	Self-Study p 13 External Review p 5	There was ambivalence about this finding, the recommendation was that all the program learning outcomes be reviewed and that the communications section could probably be integrated into one or two outcomes within the design area and include "written" communication.
Explore the idea of courses building on one another and share universal learning outcomes with at least 2 other courses.  This will help reinforce universal design skills, cross pollination between courses, and help create more manageable workloads for the students between all their required courses and reinforce the multidisciplinary aspect of the program.	Self-Study p 13 External Review p 5	The reviewers believe that the department is doing an excellent job of this already. Cross-pollination between courses seems to happen already, and both the students and alumni interviewed felt this way.

The department could consider introducing current industry trends prevalent in environmental, interactive, and communication design today, such as virtual reality (VR), augmented reality (AR), and digital marketing. These areas support the development of immersive experiences. The Design Formations curriculum already features a holistic approach. An enhanced delivery of current experiential design practice within the curriculum will ensure relevancy.		P 4
There is a need to update specific areas of the curriculum. The retail portion of the program needs to be more relevant to current practice and trends. This includes a greater emphasis on mobile, digital, social integration, brand narratives, experiential design, interactivity, and user experience design (UX). Design has evolved from a message-centered focus for a passive audience to immersive experiences and how an audience interacts and develops content collaboratively through data-driven solutions. While strong visual solutions are essential, interactive strategies and the quality of an experience are changing the field. A Program Advisory Committee will be crucial to identify and implement this need.		P 5
The reviewers feel that there is a missing component in the program: A foundation course in 20 <sup>th</sup> Century Design History would give the students more depth in their projects and help to remove the "Nowism" in the work they are creating.		P 5
