

Accessibility Survey 2024: Results

Background

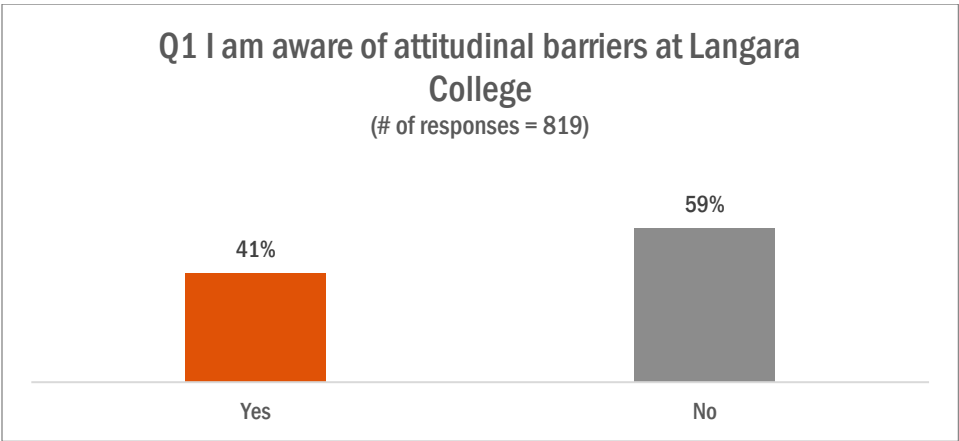
The Accessibility Survey 2024 was open to responses from October 28 to November 14, 2024. The survey link was sent to Langara’s faculty members, staff, and students via email. In total, the survey received 822 completed responses (a response rate of 4.5%). The number of respondents by question may differ from the total number of completed surveys.

The Accessibility Survey was first conducted in November/December 2023. Results from the 2023 survey are included for comparison for some of the questions.

Survey Results

Q1 I am aware of attitudinal barriers at Langara College

Attitudinal barriers are often based on stereotypes or assumptions that limit opportunities or offend the dignity of people with disabilities. A total of 41% of respondents were aware of attitudinal barriers at Langara.



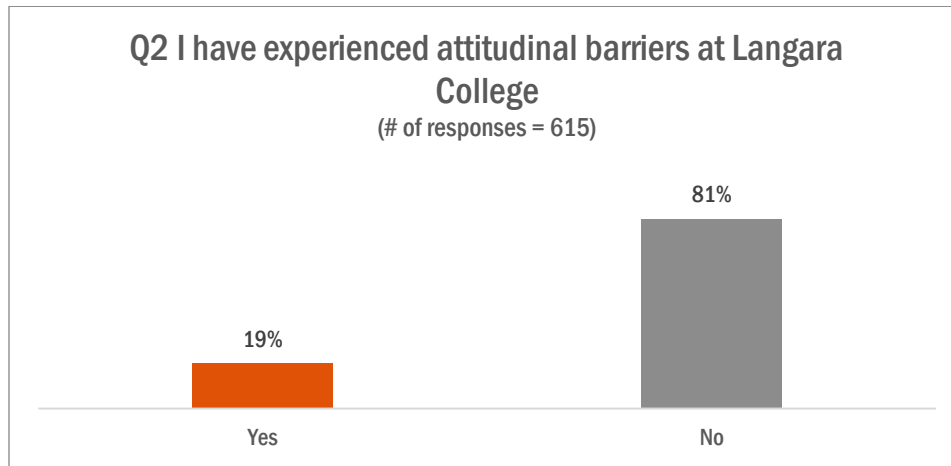
The percentage of respondents that were aware of attitudinal barriers at Langara was also 41% in the 2023 survey.

## Q2 I have experienced attitudinal barriers at Langara College

A total of 19% of respondents had experienced attitudinal barriers at Langara.



In the 2023 survey, the percentage of respondents that had experienced attitudinal barriers at Langara was 15%.

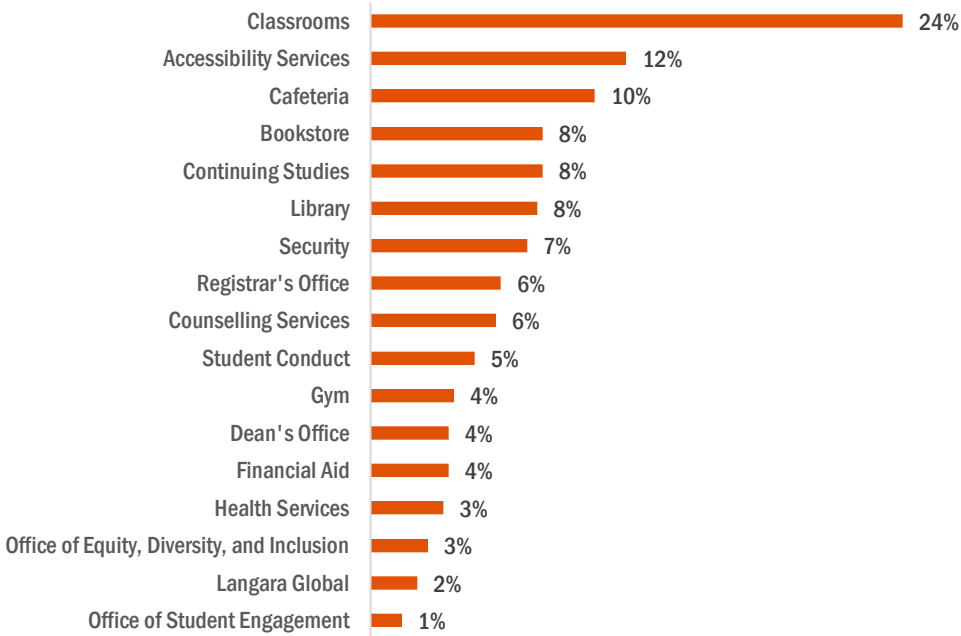
## Q3 I am aware of or have experienced attitudinal barriers at Langara College at the following locations (select all that apply)

This question was only asked of 486 respondents who said they were aware of, or had experienced, attitudinal barriers at Langara. Of these, 24% reported attitudinal barriers in classrooms. Other locations reported by multiple respondents include Accessibility Services (12%), Cafeteria (10%), Bookstore, Continuing Studies, and Library (all at 8%).

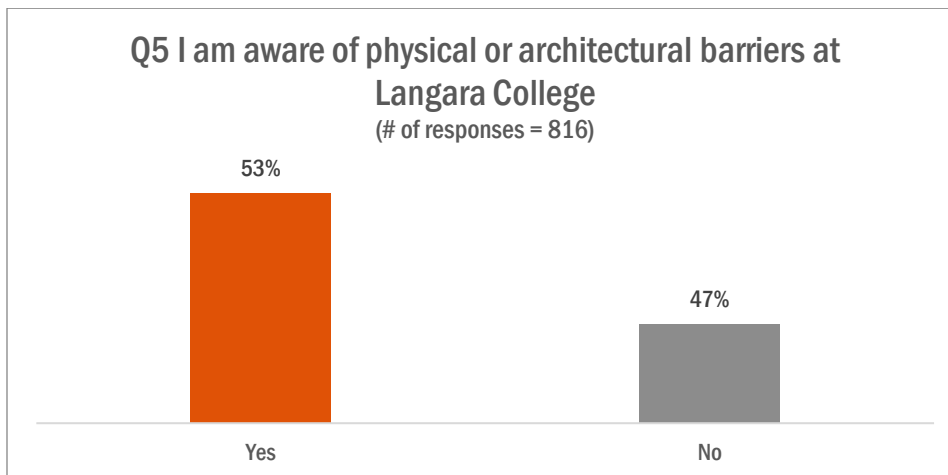

#### Q4 I have additional comments or suggestions to share regarding attitudinal barriers at Langara College

There were 87 respondents who provided comments regarding attitudinal barriers.

#### Q5 I am aware of architectural or physical barriers at Langara College

Physical barriers prevent people from accessing your services. Examples would be a classroom in which spaces between tables are too narrow for a student in a wheelchair to navigate easily or inaccessible washrooms. A total of 53% of respondents were aware of architectural or physical barriers at Langara.



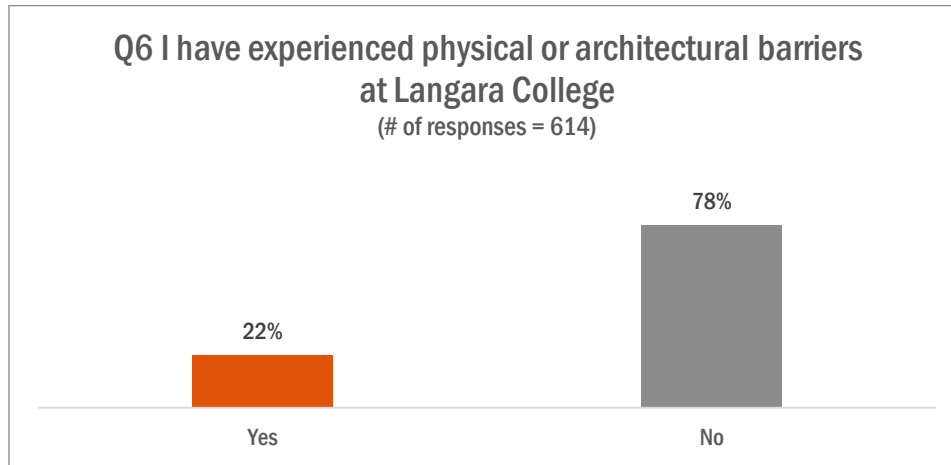
Responses were similar in the 2023 survey. A total of 54% of respondents were aware of architectural or physical barriers at Langara in 2023.

#### Q6 I have experienced architectural or physical barriers at Langara College

A total of 22% of respondents had experienced architectural or physical barriers at Langara. This was higher than 16% of respondents that had experienced architectural or physical barriers at Langara in the 2023 survey.

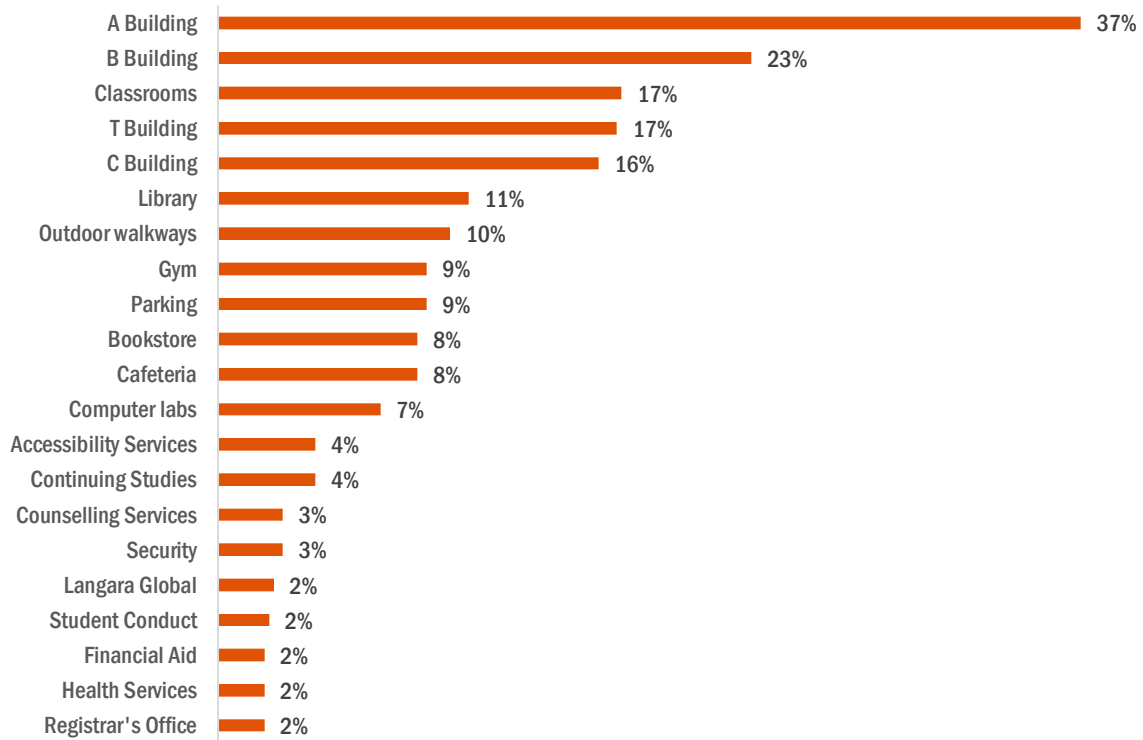
**Q7 I am aware of or have experienced architectural or physical barriers at Langara College at the following locations (select all that apply)**

This question was only asked of 507 respondents who said they were aware of, or had experienced, architectural or physical barriers at Langara. Of these, 37% reported architectural or physical barriers in A Building. Other common responses included B Building (23%), Classrooms and T Building (17%), and C Building (16%).

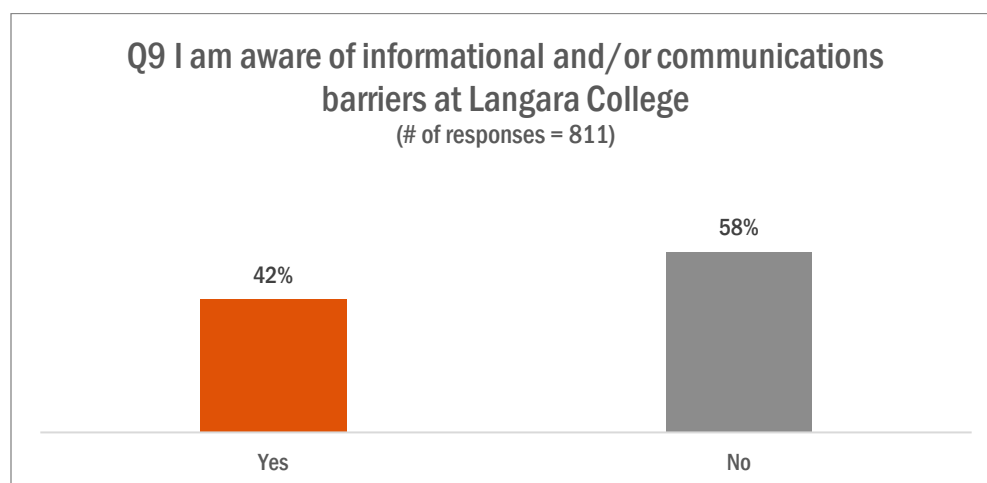

### Q8 I have additional comments or suggestions to share regarding architectural and physical barriers at Langara College

There were 139 respondents who provided a comment regarding architectural or physical barriers.

### Q9 I am aware of informational or communications barriers at Langara College

These are barriers that prevent people from understanding or accessing information. A total of 42% of respondents were aware of informational or communications barriers at Langara (down from 45% in 2023).

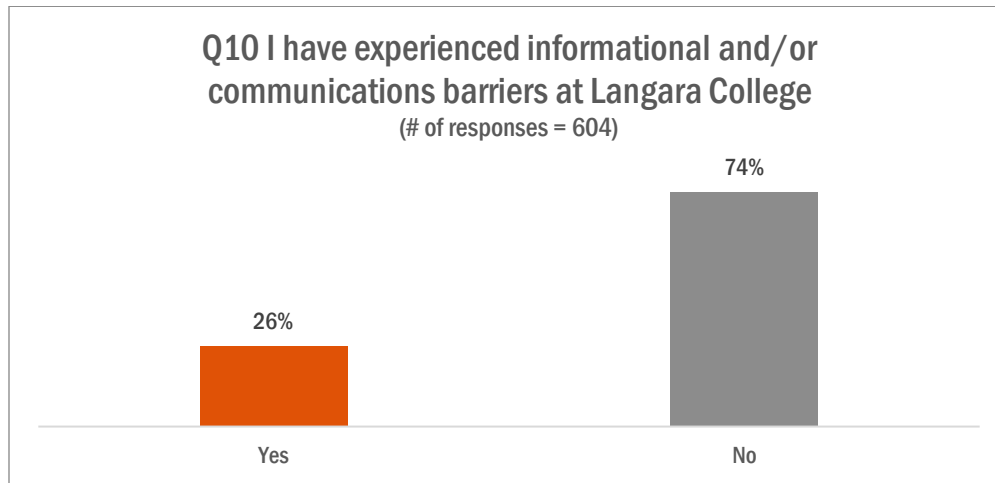

A total of 26% of respondents had experienced informational or communications barriers at Langara.



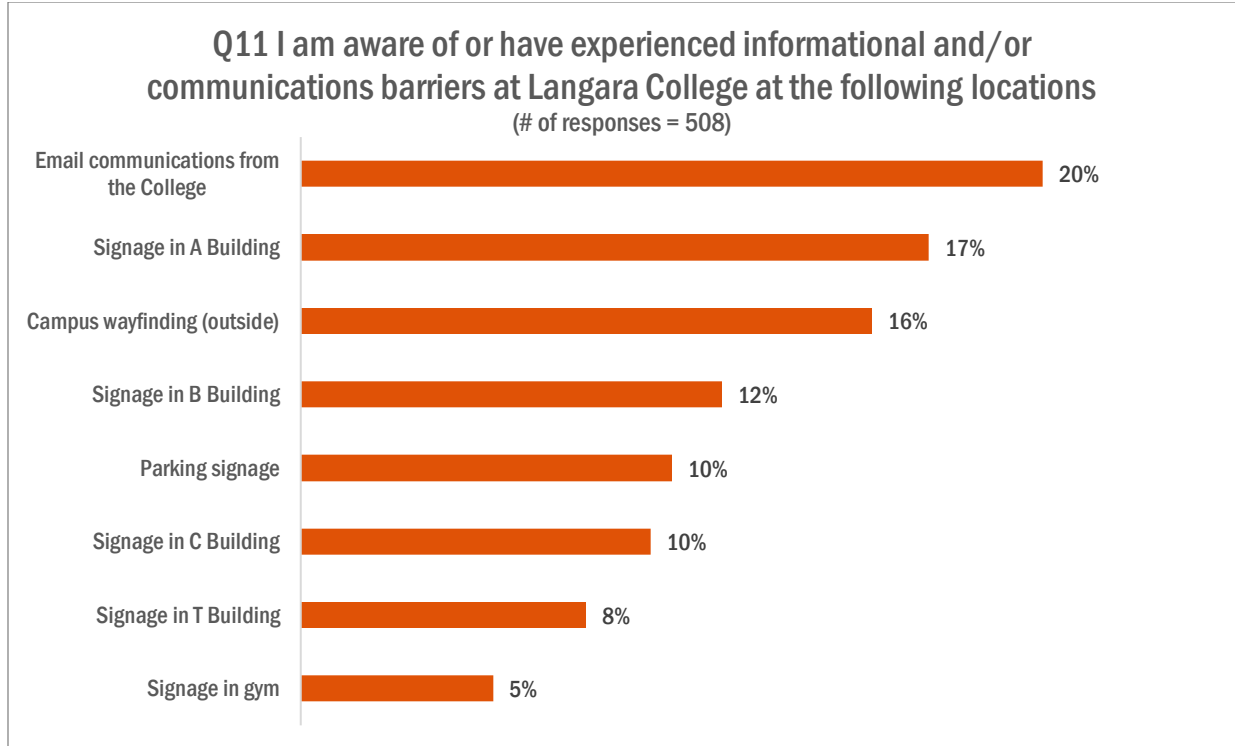
The percentage of respondents that had experienced informational or communications barriers at Langara increased from 19% in 2023 to 26% in 2024.

### Q11 I am aware of or have experienced informational or communications barriers at Langara College at the following locations (select all that apply)

This question was only asked of 508 respondents who said they were aware of, or had experienced, informational or communications barriers at Langara. Of these, 20% reported informational or communications barriers in email communications from the College and 17% also reported informational or communications barriers in signage in A building. Other common responses included campus wayfinding outside (16%), and signage in B Building (12%).

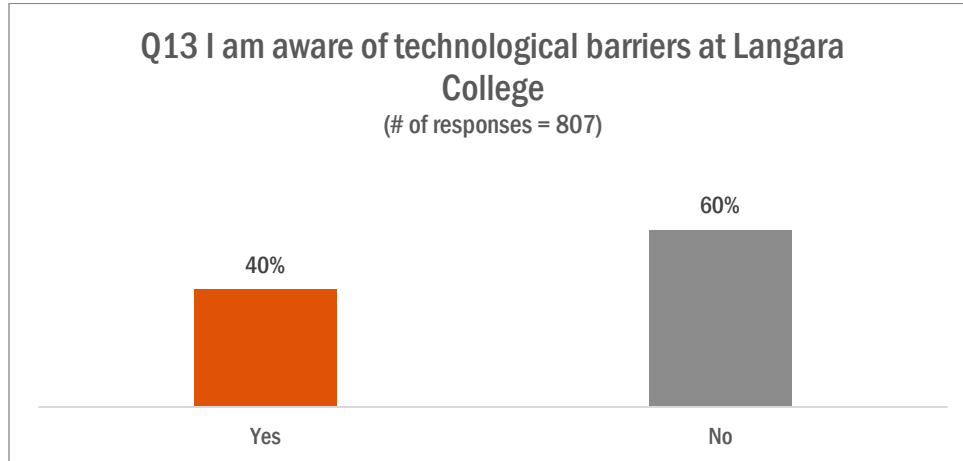
### Q12 I have additional comments or suggestions to share regarding informational and communications barriers at Langara College

### Q13 I am aware of technological barriers at Langara College

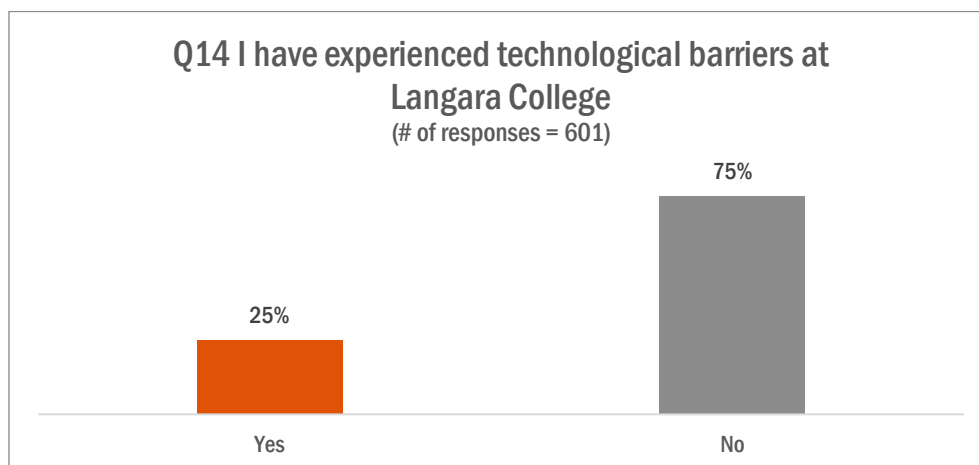
Technological barriers often relate to information and communication. An example would be a website or a course presentation that cannot be used by people who use a screen reader. A total of 40% of respondents were aware of technological barriers at Langara (down from 43% in the 2023 survey).

A total of 25% of respondents had experienced technological barriers at Langara.



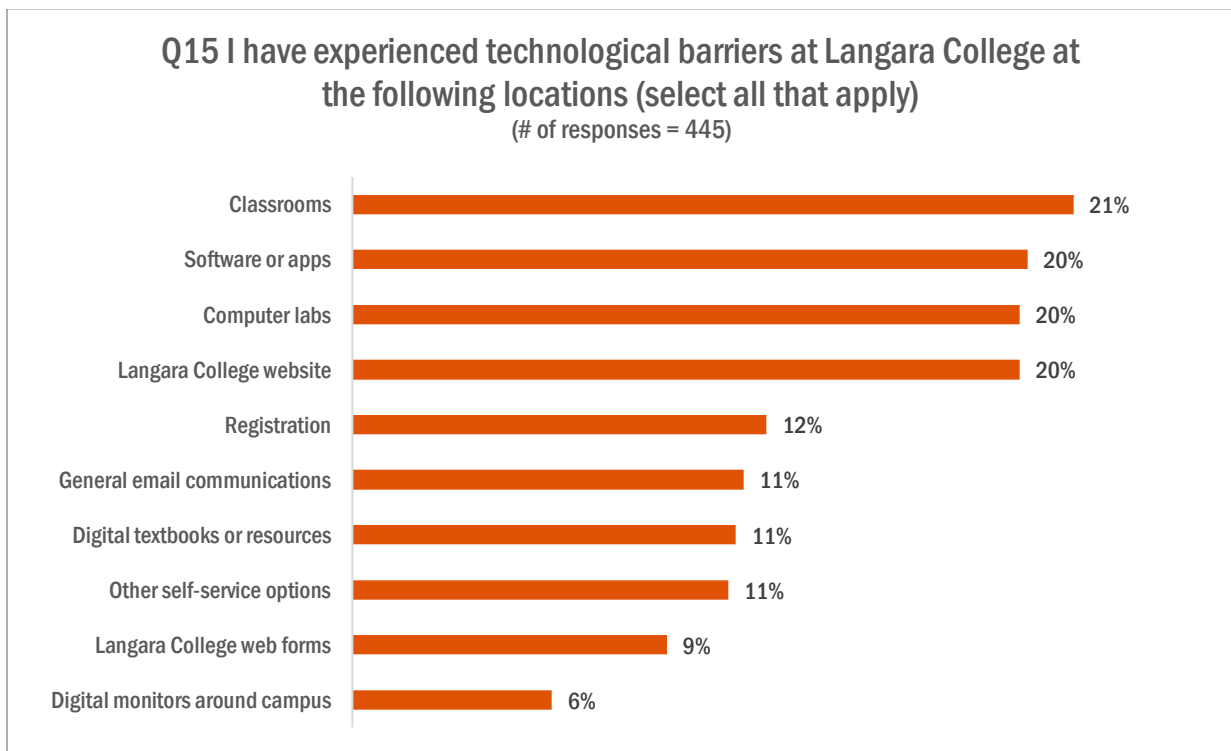
The percentage of respondents that had experienced technological barriers at Langara increased from 18% in 2023 to 25% in 2024.

**Q15 I have experienced technological barriers at Langara College at the following locations (select all that apply)**

This question was only asked of 445 respondents who said they were aware of, or had experienced, technological barriers at Langara. Of these, 21% reported technological barriers in Classrooms and 20% reported technological barriers in Software or Apps, in Computer labs, and in the College’s website. Registration accounted for 12% of technological barriers.

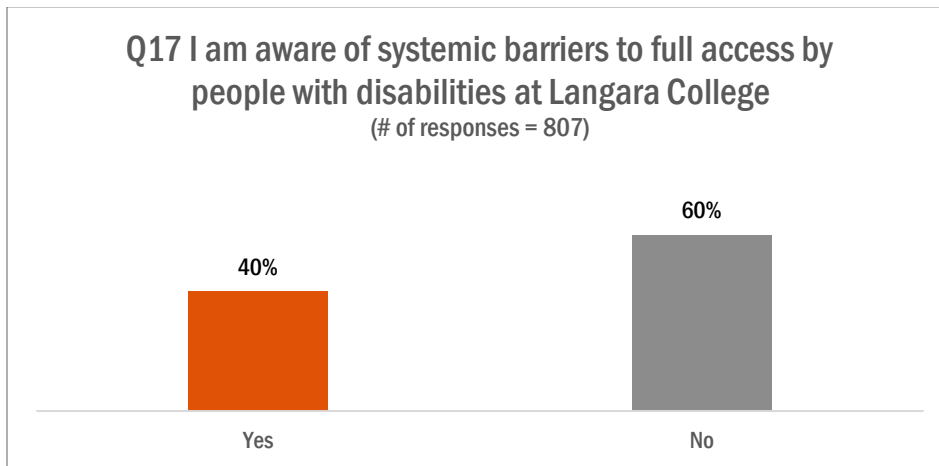

### Q17 I am aware of systemic barriers to full access by people with disabilities at Langara College

Systemic barriers are usually created by policies and procedures. Often, a policy is applied to everyone equally but has a negative impact on, or creates an access barrier to, individuals or groups of persons with disabilities. A total of 40% of respondents were aware of systemic barriers at Langara.



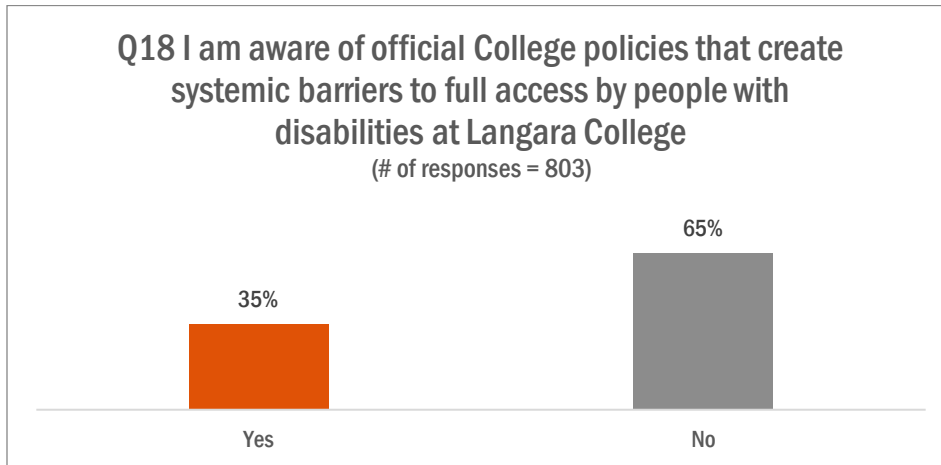
In the 2023 survey, the percentage of respondents that were aware of systemic barriers to full access by people with disabilities at Langara was 46%.

### Q18 I am aware of official College policies that create systemic barriers to full access by people with disabilities at Langara College

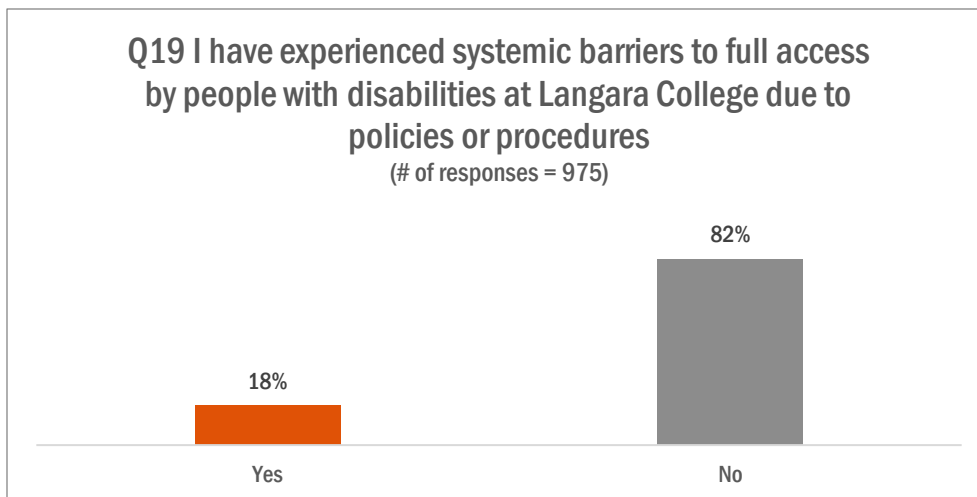
A total of 35% of respondents were aware of official College policies that create systemic barriers (down from 40% in 2023).

Responses were similar in the 2023 survey. A total of 19% of respondents had experienced systemic barriers to full access by people with disabilities at Langara College in 2023.
