Course Description, Prerequisites, Corequisites:

Social planning is about change in our communities and how we manage it effectively. Social planning takes into consideration the impact of planning and development on people. Community development is a process where community members come together to take collective action and generate solutions to common problems. This course will explore how planners can participate in and facilitate community development. It will also explore planning with First Nations.

Registration in this course is restricted to students admitted to the Applied Planning program.

Prerequisites: At least one of APPL 5110, APPL 5120, APPL 5130, APPL 5140, all with a minimum C grade.

Corequisites: None

Learning Outcomes:

Upon successful completion of this course, students will be able to:

- Identify social planning issues in Canada
- · Evaluate and recommend strategies for mitigating and addressing issues
- Relate how community development differs from other planning approaches
- Develop a process for engaging communities in tackling community issues
- Appreciate some of the key issues in planning with First Nations
- Examine the planner's role in social planning and community development
- Analyse to what extent current planning tools facilitate social planning and community development

The course is composed of three parts which will run concurrently through the thirteen weeks of the course.

- Social Planning
 - Explore the role of social planning and how it interacts with other disciplines
 - Identify and discuss key social planning issues including housing affordability, homelessness, food security and transportation.
 - Review and analyse social planning case studies and explore what actions are being taken to address it, with recommendations as to what planners can and should be doing
- Community Development
 - Explore the different practices of community development
 - Analyse the impact of community development on building resilient communities
 - Review and analyse community development case studies and identify the role of planners in facilitating community development
- Planning with First Nations
 - Learn about First Nation history and development in BC
 - Explore contemporary First Nation issues including Treaty and traditional territories
 - Understand the planning context in First Nations
 - Apply community development and inter cultural planning principles in a First Nation context
